AMENDMENT TO DECLARATION OF COVENANTS CONDITIONS AND RESTRICTIONS OF TURNBERRY PLACE

This is an Amendment (the "Amendment") to the Master Declaration of mants, Conditions and Restrictions of Turnberry Place Owners' Association, Inc. recorded in Official Records Book 1689 beginning at Page 866 of the Public Records of Okaloosa County, Florida (the "Covenants, Conditions and Restrictions") which is made by Bluewater Bay Development Company, Ltd., a Florida Corporation ("Developer" and former owner) as defined in the Covenants, Conditions and Restrictions defined in the Covenants, Conditions and Restrictions.

This Amendment is being made pursuant to paragraph (35) ("Amendment of Restriction with Consent of Owners") of the Covenants, Conditions and Restrictions. Section 12 ("NO PARKING OF VEHICLES, BOATS, ETC") is hereby amended to read as follows: "Section (12) There shall be no overnight parking of any wheeled vehicles on the public rights-of-way of the Subdivision. No wheeled vehicles of any kind (mobile homes, motor homes, self contained or otherwise, travel trailers, trucks and campers) boats or self contained or otherwise, travel trailers, trucks and campers) boats or any offensive objects may be parked or kept on public rights-of-way of the Subdivision or in the driveways, front, side or rear yard area of any lot (improved or unimproved) except that passenger vehicles may be parked on a temporary basis in the paved driveway serving a lot; and except that homeowners may park an RV temporarily on their driveway while actively loading, unloading or cleaning the RV, but for no more than 24 hours in a seven day period. Boats or wheeled vehicles may be kept completely inside a garage located on the lot. No trailers or habitable motor vehicles of any nature shall be kept for use on any lot (improved or unimproved) except within a fully enclosed garage. Disabled vehicles or vehicles under repair may be kept only within the garage located on said lot.
